



Bike Box Rental Terms and Conditions

Provider: Rapid Snail Racing ('we,' 'our,' or 'us')

These Terms and Conditions ('Terms') apply to the rental of bike boxes from Rapid Snail Racing. By renting a bike box, the customer ('you' or 'your') agrees to the following:

1. Rental Fees and Deposit

The rental fee is \$40 per week. Rental is charged by full week; partial weeks are not prorated. The maximum rental period is 12 weeks. A deposit of \$500 (minimum) is required at the time of rental. Rental fees must be paid in full before the bike box is released. The deposit will be refunded upon return of the bike box, provided it is in acceptable condition.

2. Rental Period

The rental period begins on the date the bike box is collected or delivered to you and ends when the bike box is returned. Extensions must be requested in advance and are subject to availability but cannot exceed 12 weeks in total.

3. Customer Responsibilities

You agree to use the bike box for its intended purpose only, take reasonable care of it, protect it from damage, theft, or loss, not lend or sublet it without written consent, and return it by the agreed-upon date.

4. Condition, Damage, and Loss

The bike box must be returned in the same condition as when it was rented, normal wear and tear excepted. We reserve the right to deduct from the deposit costs of repair, cleaning, or replacement for damage, missing parts, or excessive dirt. If the cost exceeds the deposit, you are responsible for the balance. In cases of total loss or theft, the full replacement value will be charged.

5. Deposit Refund

Deposits will be refunded within 7 business days after inspection, using the same payment method. Refunds may be reduced by repair or replacement costs if applicable.

6. Liability

We are not responsible for damage to your bicycle, equipment, or belongings while using the bike box. You are responsible for proper packing and securing of your bike. We do not guarantee airline acceptance.

7. Termination of Rental

We reserve the right to terminate the rental and reclaim the bike box at any time if these Terms are violated.

8. Governing Law

These Terms are governed by the laws of the Province of Ontario, Canada, and applicable federal laws.

9. Agreement

By renting a bike box, you acknowledge that you have read, understood, and agree to these Terms and Conditions.
